If you register too close to the hearing date, we may not have enough time to arrange for an interpreter. If you request an interpreter, we will make every reasonable effort to have one present.

Hearing Exhibits: If you have any hearing exhibits to which you will refer during the hearing, please email them to the OCA at consumer@paoca.org. The OCA will forward the exhibits to the Judge and all parties. Exhibits **must be received** by 3:00 p.m. on Wednesday, August 10, 2022.
